BILLS INTRODUCED IN THE VERMONT HOUSE, TO SUPPORT!

H283: Fundamental Right to Health Decisions & Bodily Autonomy, Protected –

This bill recognizes and protects the fundamental right of all persons to make medical decisions concerning their own bodily autonomy, and to be free from incentives (coercion) or discrimination (penalty).

H322: Vaccine “Opt-Outs” for Students, Expanded -

This bill recognizes the right of all parents and students to hold medical, religious and conscientious beliefs opposed to vaccination. It restores the philosophical exemption, which was banned in 2016, and also removes the coercive language, which was added in 2012.

H323: Vaccine Adverse Events, Reported Publicly –

This bill requires the state to provide an annual public report on vaccine adverse reactions experienced by Vermonters.

H452: Vaccine passports, Prohibited –

This bill would ensure that no person in VT is coerced or forced into releasing private, protected medical information regarding vaccination status, proof of immunity or results from an invasive medical test as a condition of entry/access. Protects your right to healthcare, education, travel and free participation in life, as all others would enjoy, regardless of protected medical information status.

We the undersigned hereby urge our elected representatives and senators to protect the rights of the People, their constituents, by banning vaccine passports or any other coercive tool of private or public entities and by establishing in law our unequivocal right to medical freedom.
